#### The Homeowners Association of Eagle Creek Inc. Tennis Committee Charter

WHEREAS, the Board of Directors of The Homeowners Association of Eagle Creek, Inc recognizes the benefits of utilizing the efforts of volunteer members to assist Management in reviewing and making recommendations relative to the Tennis Court needs and requirements.

IT IS THEREFORE RESOLVED, that the Board of Directors of the Association hereby establishes the Eagle Creek Tennis Committee ("Tennis Committee") and this Charter as follows:

#### DEFINITION

The Tennis Committee is a committee of the Homeowners Association of Eagle Creek, Inc. (HOA) The Tennis Committee advises and makes recommendations to the HOA in the maintenance, operations, fees, and promotion of the tennis courts.

#### MANNER OF ORGANIZATION

#### Membership:

The Tennis Committee shall consist of at least three (3) Members who shall be owners of the Association and appointed by the Board of Directors. The maximum amount of committee members shall be five (5). The Committee may have one (1) Village Representative maximum.

#### Term:

The Tennis Committee members shall serve for one (1) year at the direction of the Board and shall report to the HOA. Generally, the Board of Directors will appoint members to this standing committee on an as needed basis.

#### Appointment of Officers of the Committee:

Committee Chairperson – The Tennis Committee Chairperson shall be a member of the committee and shall be appointed amongst committee members.

#### Termination of Committee Membership:

The Board of Directors may remove a member of the Tennis Committee, with or without cause, at any time and without advance notice. Vacancies may be filled by the Board of Directors. While no cause for removal is required, the Board will be inclined to remove a Tennis Committee Member for non-participation, nonattendance, disruptive behavior, actions contradictory to the best interests of the Association, divisive actions in nature against the Association, or any action the Board deems inappropriate or a conflict of interest.

#### MANNER OF OPERATION

The Tennis Committee shall conduct its business in the best interest of the Association, and in accordance with Florida Statutes, this Charter, the Association's Declaration, Articles of Incorporation, Bylaws and Rules & Regulations.

Committee Duties:

Monitor, analyze, advise, and make recommendations regarding the condition and management of the tennis courts to the Homeowners Association in order to preserve and enhance such amenities, and encourage participation by members.

Promote appreciation for the rules and etiquette of the game of tennis.

Make recommendations to the Homeowners Association regarding tennis programs and authorized tennis instructions (tennis pros).

To support and assist the Homeowners Association in developing communications regarding the tennis courts and authorized tennis programs to Association Members.

To support and assist the Homeowners Association in developing long-range plans for tennis facilities, programs and operation.

Establish a process for identifying the tennis court needs of the Homeowners Association of Eagle Creek.

The Association will be responsible for all official communication and advertisement of Homeowners Association of Eagle Creek tennis courts.

Committee Members may not use their position on the Committee for personal gain, nor be allowed to advertise for any company, business, service, or promote agendas unless expressly permitted by the Board of Directors or at an event where advertising has been allowed.
